### **A SARK LARK UPDATE**

#### **AN UNFORTUNATE OFFSHORE ASSOCIATION**

In a previous Sark Lark update, we listed the current known directorships of Bertha Cole, wife of Conseiller Peter Cole who is Deputy Chairman of the GP&A – Sark’s most powerful committee – as well as Chairman of the Shipping Committee and ex-husband of Jan Guy, Chairman of the Harbours & Pilotage Committee.

On 1<sup>st</sup> October 2008, Mrs Bertha Cole signed on as director of the UK-registered company Nateforce Ltd, thereby linking herself with a rather colourful business associate – ex-director Alistair Matthew Cunningham. Mr Cunningham, formerly of South View House, Sark and Weybridge, Surrey as well as two different addresses in Nicosia, Cyprus, is now listed at Companies House with a further address in London. He is an astoundingly prolific company director with a total of **573** directorships in the UK, over 50 of which are current.

Before taking a look at the impressive list below, a reader should of course bear in mind that these data are from the UK company register alone. There is no access to the registers of the famously secretive off-shore tax havens of Bermuda, the Cayman Islands and the BVIs, to mention but a few, but taking into consideration Mr Cunningham’s Cyprus addresses, it would be surprising indeed the activities of Mr Cunningham and his associates were limited to UK-registered companies only.

How is it possible for any company director with more than 50 simultaneous appointments to carry out the practical duties and moral obligations that this position entails? Sark News maintains that this would be an impossible task but, unfortunately, the GFSC as well as Conseiller Charles Maitland, Chairman of the GP&A, prefer to close their eyes and pretend that this Sark Lark “nonsense” no longer exists.

How can Sark possibly overcome its reputation as a place for dubious financial practices when a few of its residents continue this secretive, shady activity? Mrs Cole’s association with Mr Cunningham is unfortunate, indeed. In the eyes of the world, it can only serve to undermine the credibility of Mrs Cole herself, of her husband’s political work and of the Island of Sark in general.
